The Saskatchewan Milk Marketing Board is required to undertake appropriate due diligence for every quota transaction in Saskatchewan and makes no guarantees that it will have sufficient time to complete such due diligence even if the Application is received by the 6th of the month. Buyers and Sellers should not assume that applications will be processed within such period.
